I hereby acknowledge the risk and danger to myself and property while upon the premises of the Grafton County Fish and Game Association, either as a spectator or a competitor or in assisting in any events held upon said properties and I do so voluntarily with reliance upon my own judgment and ability and not upon the judgment and ability of others and accept the conditions of the property, equipment and facilities now existing on the Grafton County Fish and Game Association and I hereby assume all risks for loss, damage or injury, including death, to myself and property for any cause whatsoever and whether or not attributable to the negligence of any person associated with the Grafton County Fish and Game Association.

GRAFTON COUNTY FISH & GAME ASSOCIATION RELEASE,
ACKNOWLEDGMENT OF RISK, WAIVER, INDEMNIFICATION AND COVENANT
NOT TO SUE

This is a legally-binding liability release, waiver, indemnification, and covenant not to sue made by [REDACTED] (hereinafter referred to as "RELEASOR") to the GRAFTON COUNTY FISH AND GAME ASSOCIATION, ITS OFFICERS, DIRECTORS AND REPRESENTATIVES (hereinafter collectively referred to as "RELEASEE").

RELEASOR desires to attend or participate in functions, events or activities offered at the Grafton County Fish and Game Association Inc. The Grafton County Fish and Game Association offers a myriad of functions, events and activities on its property located on Trues Brook Road in West Lebanon, New Hampshire, including, but not limited to, shooting shotguns, rifles (large and small bore), muzzleloaders, handguns, and archery related sports.

RELEASOR understands and accepts that the intent, purpose and effect of this document is to release RELEASEE from any and all liability for any personal injury sustained by RELEASOR while on RELEASEE's property, and/or while attending or participating in functions, events or activities on RELEASEE's property, even if the cause of such personal injury is RELEASEE's negligence.

ACKNOWLEDGMENT OF RISK

RELEASOR fully recognizes that there are dangers and risks to which he/she may be exposed as a result of attending or participating in functions, events or activities on RELEASEE's property. RELEASOR understands and accepts that use of firearms (i.e. shotguns, rifles, muzzleloaders and handguns) and archery equipment is not risk free. The same elements that contribute towards the unique character and fun of use of firearms and archery can also cause loss of or damage to equipment or personal possessions, injury, illness, or in extreme cases, permanent trauma or death. RELEASEE does not want to heighten or reduce enthusiasm for the sport of shooting and archery, but does want members, guests and participants to know, in advance, what to expect, and to be informed and mindful of some of the possible risks. There are various inherent dangers associated with the use of firearms and archery equipment, to include malfunctioning equipment, ricochets, and misfires. In addition participants may be exposed to airborne or surface contaminants resulting from the use of firearms. Participants and those attending functions, events or activities may be exposed to dangers and injury stemming from their own actions or actions by others. It is possible to be injured if one is not paying attention to his/her own actions and/or the actions of others. Participants, attendees and their guests must maintain themselves within the permissible areas such as to not unreasonably expose themselves to accidents or injury. While on the property owned by RELEASEE, RELEASOR will be responsible for his/her own actions, and those who accompany him/her, including children and guests.

RELEASE, WAIVER, INDEMNIFICATION AND COVENANT NOT TO SUE

RELEASOR agrees to indemnify and hold RELEASEE harmless from all claims, damages, losses, injuries and expenses arising out of or resulting from attending, viewing or participating in any activity occurring on RELEASEE's property. RELEASOR further agrees to release, acquit and covenants not to sue RELEASEE for any liability, actions, causes of action, claims or damages, damages in law or remedies in equity of whatever kind, including for the negligence of RELEASEE, arising out of RELEASOR's attendance, viewing or participation in any function, event or activity offered or occurring on RELEASEE's property. RELEASOR acknowledges and accepts that he/she will not/cannot sue the RELEASEE, including a suit to collect monetary compensation, for any damages or injuries that may occur to RELEASOR while on RELEASEE's property, including damages or injury that are attributable to RELEASEE's negligence or which are associated with RELEASOR's attendance, viewing or participation in any function, program or activity offered or occurring on RELEASEE's property.

RELEASOR hereby assures RELEASEE that there are no health-related reasons or problems that preclude or restrict RELEASOR's attendance, viewing or participation in any function, event or activity offered on the RELEASEE's property. RELEASOR understands that this Release means he/she is giving up, among other things, rights to sue the RELEASEE for personal injuries (including death), damages, or losses RELEASOR may incur or sustain, including injuries, damages or losses associated with RELEASEE's negligence. RELEASOR also understands that this Release binds his/her family including minors, heirs, executors, administrators, and assigns. RELEASOR agrees that the site of any lawsuit against RELEASEE and the law governing any such lawsuit shall be in the State of New Hampshire. The terms of this agreement shall continue and be in effect even after the attendance, viewing or participation in any function, event or activity offered on RELEASEE's property has ended. RELEASOR hereby agrees that if the RELEASEE is forced to defend any action, lawsuit or litigation stemming from or involving RELEASOR's conduct, RELEASOR agrees to pay RELEASEE's costs and attorney's fees if they successfully defend such action, lawsuit or litigation. RELEASOR acknowledges and represents that he/she has adequate health, disability and life insurance for his/her family and himself/herself necessary to provide for and pay any medical costs that may directly or indirectly result from RELEASOR's participation in activities on RELEASEE's property, and RELEASOR will indemnify and hold RELEASEE harmless for any such medical costs. RELEASOR accepts and represents that he/she will not be intoxicated or under the influence of drugs while participating in functions, events or activities occurring on the RELEASEE's property.

RELEASOR confirms that he/she has read this document in its entirety, including information about some of the possible risks in the functions, events or activities offered at the GRAFTON COUNTY FISH AND GAME ASSOCIATION. RELEASOR assumes full responsibility for himself/herself for bodily injury, illness, death and loss of personal property and any expenses as a result of his/her negligence, the negligence of others, and/or the acts or negligence of RELEASEE.

A copy of this release can be used as if it were an original. If any one part is declared unenforceable, the remainder remains enforceable.
